


#### WHAT DO I NEED TO APPLY FOR MY INDIAN VISA?

#### **TOURIST VISA:**

One completed application form (see below).

Original passport valid for at least six months with two blank pages.

One recent colour passport sized photograph taken against a white background on standard photographic paper.

Proof of residency in Ireland (utility bill or bank statement) with name and address of the applicant clearly printed on the document. The applicant must provide two proofs of residence: utility bill/bank statement that is two years old and recent utility bill/bank statement (issued within 3 months prior to application). They are also required to provide a copy of their GNIB card if they are non European passport holders.

Visa processing fee.

**IMPORTANT:** Once you have completed your application form please send it via email to india@visafirst.com. We will then email you with a typed version of your application. All you need to do is print out the form from your email, sign it and then post it back to us along with the rest of the required documents listed above.

**NB:** Non-Irish passport holders are additionally required to provide proof of residential address in Ireland (utility bill, bank statement, etc. stating applicants full name and address in Ireland).

#### **BUSINESS VISA:**

All documents required for the Indian tourist visa plus the following:

Letter of employment. The letter must be an original, a copy will be rejected. The letter must contain a company stamp and must be signed by a superior or by the HR department. It must also include the following:

- Introduction of the company: stating the nature of the business.
- Introduction of the applicant: job title of applicant and details of specific role within company.
- Applicant's passport details: passport number, date of issue and expiry.
- Nature of visit to India: purpose of visit, companies to meet and an itinerary of the visit.
- Duration of visit: arrival and departure dates.
- Number of visits requested: future trips that may be planned.
- Financial responsibility: stating that the company will cover all expenses.

**NB:** If an applicant is employed by a company that doesn't have an office in Ireland, the documents cannot be submitted to the Indian Embassy in Dublin, but in the country of the employers location.

Letter of invitation. The letter should be on headed paper from an inviting company in India and should state the following:

- Addressed to the Embassy of India in Dublin.
- Introduction of the company: stating the nature of the business.
- Applicant's passport details: passport number, date of issue and expiry.
- The purpose of the visit: the duration of stay and the number of visits that are required.

**Please note** that it is at the discretion of the embassy to request any additional documents. The outlined processing time is given as a guideline and processing times may vary.



**NB:** Additional documents may be required before a final decision on the application is made.

**NB:** Please note that if you are of Sri Lankan, Pakistan or Bangladesh origin different application conditions may apply to you. The embassy may request additional documents to support your application. Please contact the Visa First help desk if this applies to you.

#### Where should I send my documents?

Please e-mail your documents to <a href="mailto:india@visafirst.com">india@visafirst.com</a> with the completed application form. Please be advised that Visa First will contact you regarding posting your documents to our office - Visa First, 14 St. Stephen's Green, Dublin 2, Ireland.

#### How long does the visa take to be organised?

The standard processing time is 10 working days from when we receive your passport and application.

\*NB: Please note that there is no express visa option for non Irish passport holders.

#### How much time can I spend in India?

Tourist and business visas are automatically granted for six months and are multiple entry. It is also possible to apply for a twelve month business visa however, applicants may have to apply directly at the embassy. Please also note that the validity of all Indian visas are effective from the date of issue.

You must travel with the same passport you hold at time of completing this application. If you obtain a new passport after your visa has been issued, please contact the Visa First help desk for advice. In this case reallocation fees may apply.

Visa First advises against purchasing restricted or inflexible tickets prior to visa issuance. Processing times shown on this application are standard processing times. While Visa First makes every effort to ensure that visas are processed according to advertised timelines, Visa First does not accept any claims for delays caused by postal strikes or delayed post handling by postal companies or embassies which are outside of our control.
